# LVSD – Doug Edwards

- C37.13 PAR was revised and approved by NESCOM in 10/07. Forecast to go to ballot fall 2007.
- C37.27 PAR was revised and approved by NESCOM in 10/07. This is being reviewed for withdrawal or update.
- C37.14 Reaffirmation was initiated for C37.14 and ballot invitation is out. WG is joint WG with Vehicular Transit group who are meeting week of 10/22/07.
- C37.16 Currently active with on-going revision activities. Forecast to go to ballot fall 2007.
- C37.17 Currently active with on-going revision activities.

- Ken Edwards / Mike Wactor to communicate when system is operational and will provide training documentation.
- Individual members must update their Activity Profiles
- Chairs (S/C and WG) will update and maintain the Project membership status (Observer, Member, Other???)

## C37.100.1

There is need for copies of document for use by WG's for the upgrade of the individual standard. Process is for WG chair to request from IEEE (Matt Ceglia). Document will be provided with some disclaimers concerning copying and usage.

## C37.100 Definitions

There was an evaluation of an on-line definition (IEEE 100 is old reference) system. Conclusion was that the system works. There issue is with the data itself which is the task at hand as to how to update.

## Options:

- 1. Make C37.100 a "Stabilized Standard." Answer No because there are update requirements.
- Drop C37.100 and instead use the on-line definitions system. Details are not available for the online system (cost, access and updating process). From this, action consideration is to consider letting this be Administratively Withdrawn.

Decision postponed pending update from IEEE.

#### 3000Vdc (HVCB) versus 3200Vdc (LVSD)
