Patents

The IEEE-SA rules on Patents were reviewed prior to further discussions. The five slides were shown. An opportunity was given for participants to identify patent claims, patent applications, and/or holders of patent claims/patent application claims that may be essential for the use of a standard. There were no responses.

The IEEE-SA patents policy must be reviewed during every working group meeting. The rules can be accessed on http://standards.ieee.org/board/pat/pat/slideset.ppt.

The meeting was opened with introductions and review of proposed agenda. The following is in general what was discussed:

- Much discussion as to whether this document should be a Guide or a Standard. It was
 again agreed that this document should be a Guide as this document as it is presently
 only references the appropriate standards for each component and relies on the
 manufacturer to ensure that each component meets the appropriate standards. There are
 some areas in the document that need to be addressed and they will be looked at as the
 WG reviews the content of the guide.
- The wording of the Scope and Purpose for the proposed PAR was developed and agreed upon by the Task Force. J. Smith will use this to create and submit a PAR before the next meeting.
- The Working Group will be using MYBallot.
- There was discussion as to whether to remove the dates of the ref standards. The decision was made to leave them on for the time being.
- Each section of the C37.121 was assigned to attendees at the meeting for the next meeting in Sept/09. The person assigned to each section will edit their assigned section in the existing C37.121-1989 word document and forward their edited section to J. Smith.

J. Smith will then combine all of the edited sections into one document and send out to the Task Team for review at the next meeting.
