  - c. Resolution of comments on negative ballots resulted in changes to the document; recirculation is planned for June.
  - d. Among the ballot resolutions which were voted upon, the proposal to increase the minimum number of 'extra' auxiliary contacts available to the user on breakers not intended for use in metal-clad switchgear be increased from 2 'a' and 2 'b' to 8 'a' and 8 'b' was not accepted by the working group.
