Minutes of WG PC37.04 Standard for High Voltage Circuit Breaker Monday 9 October, 2017 8 to 12 am Portland, Maine

- I Welcome IEEE C37.04 revision to include addendums, C37.06 and NEMA SG-4
- II Introductions

Meeting opened with 97 individuals in attendance: 37 of 51 members and 56 guests. A quorum was present.

- III A call for additions or corrections to the published minutes was made. Only correction to the minutes was to reflect the change to the PAR is 2017. A one year extension has been requested at the meeting.
- IV No essential patent knowledge was called. No mention of applicable essential patents.
- V Old Business
- a. The PAR is valid through 2019, but current document expires at the end of 2018, at which time IEEE will administratively withdraw the standard and there will be no standard. It is important that the work finish before the document expires.
- b. It was noted initial ballot comments had been mostly reviewed. The ballot 73% affirmative, 90% returned.
- VI New Business: Comment Resolution
- a. Review of comments: J. Webb -- discussion of re-organization of clauses 7.4 & 7.5 under revision to document in response to comments.
- b. Discussion of trip-free requirements and reorganization of the document bringing to more prominent position.
- c. Discussion of temperature rise requirements and changes to previous version of C37.04 and current draft does adopt requirements of C37.100.1. Focus was likely that properly we should take exception to C37.100.1 with respect to different limits for aluminum. Members requested to vote on position on upcoming ballot. Lower temperature on Aluminum only. Lower temperatures on Aluminum and copper. Requirement to follow plating lowest or highest temperature to apply if one side plated.
- d. Correct minimum arcing time to arcing time. Diverged into discussion on 'rating' arcing time on ms or cycles. Proposal to change back to cycles in tables of C37.04.
- e. Discussion of diagrams for bushing CT's: consensus was that needs to remain normative.
- f. [Further elaboration on status of NEMA SG-4 (from where CT bushing drawing originated),
- g. Santosh elaborate on requirements (or lack of) for terminal loading on indoor breakers.
- h. Esco Revision of manual releases. Discussion on need to differentiate between a local operating method and an emergency operation. [Dullni / Hua] Further Neil McCord will also add wording on situation where design of CB is such that *any* operation of the CB under certain conditions (e.g. no SF6) will damage the CB can be an exception to the manual operation clause.
- i. i-605: Balloting draft still has requirement for ground pad.

- n. Definitions are / will be harmonized with C37.100.5 where definitions overlap. Not removing definitions which may be useful to readers of C37.04 simply because they are picked up by C37.100.5, but we will not trigger 2 nearly identical definitions.
- o. i-596: 1200 kV will not be incorporated into this revision.
- p. i-244: Sound pressure levels with respect to dB vs. dBA,
