Erin Spiewak:

- For other Standards, if references are taken from C37.100.1-2007 and used in a document, IEEE Copyright Manager does want reference to source of the text being copied. How to do this? Erin guidance is to:
 - o Footnote in the document
 - o Provide email with description of the content “borrowed” to Erin Spiewak.
- For copying text originally from IEC, then footnote reference to IEC would be appropriate.

Concerns expressed for future similar copyright issues when IEC text is used.

Potential for Dual Logo options. Concept has been discussed with mixed viewpoints of likelihood of IEC TC supporting or not.

Discussion of re-balloting C37.100.1-2007 with only minor (e.g references) changes, which would drive need for a new PAR and re-balloting.

Revising C37.100.1 for inclusion of LV Common Clause issues discussed, no specific directions determined.

Options were reviewed. New option identified to re-ballot C37.100.1-2007 (minor revisions, e.g. references) to extend the life of the Standard. This concept was supported.

Document status report of C37.100.1-2017

- ❑ Approximately 1.5 years ago it was submitted to RevCom for approval.
- ❑ RevCom review was tabled pending copyright approval from IEC.
- ❑ Late 2017 IEC rejected IEEE's request for use of copyrighted IEC 62271-1:2017 material.
 - ❑ IEC policy limits duplication of copyrighted material to **less than 10%**.
 - ❑ Dave Stone estimated that -2017 had duplicated **approximately 85%** of IEC 62271-1:2017.

Document status report of C37.100.1-2007

- ❑ So, what about C37.100.1-2007?
- ❑ This standard is set to expire at the end of 2018.
- ❑ However, it is still a valid document, and will remain commercially available as long as there is demand.
- ❑ There is no IEEE policy against making normative references to expired documents.
 - ❑ **New standards can still reference C37.100.1-2007!**

For new and in-process standards....

ADSCOM requests each working group to revise their document to use IEC 62271-1:2017 as the common clauses document and remove all references to the 2017 draft of IEEE C37.100.1. As an alternative the working groups may use C37.100.1-2007 either in whole or modified as needed. Please understand IEC 62271-1:2017 should be stable until 2027. ADSCOM will be requesting an extension of IEEE C27.100.1-2007 so that it will remain active until 2019. This request is not a guarantee but only a stopgap to provide time for the working groups to modify their document to use IEC 62271-1:2017.

Which means....

- ✓ **Reference to IEEE Std C37.100.1-2007**
- ✓ **Reference IEC 62271-1:2017**
- ✓ **Reference IEC 62271-1:2017 with exceptions**
- ✓ **Forego Common Clauses (IEEE or IEC) and define the requirement within your draft standard.**


