Gas leakage

- A member pointed out 62271-1 7.8.1; table 15 permissible gas rates does not match with recommendations from task force.
- The advantage of having it in is consistency with "rest of the world". Member will go back to task force and look at C37.122 and make recommendation to working group..
- It was proposed that best practice would be to have same values in new C37.100.1 as in IEC 62271-1.
- Chair will go revisit matter with task force to consider 62271-1 values or justify reason for difference.
- Various tables agreed to put in and exclude
 - o IEC voltage tables previously counted against copyright issue
 - Gas leakage rate (see above)

- Early decision was to exclude Annex D table D1 "list of ref documents for aux and control circuit components". Likely no interest to point to IEC documents for each device.
 - Refer back to task forces
- Refer back to C37.04 for pollution
- No argument for changing altitude correction factors
- Add type test tolerances
